- 7. Various outdoor Sports activities such as Cricket, Badminton, Volley Ball, Kho-Kho, Football, Kabadi etc
- 8. Many indoor games such as Table Tennis, Carrum, Chess, Judo & Karate.
- 9. Music and Dance, Art & Craft are taught by trained teachers.
- 10. R.O. Water with cooling facility.
- 11. Trained Security Guards
- 12. A fleet of School bus for safe journey.

Members of Parent side were of the view that no fee will be increased this time because in the last session 10% fee has been already increased. While the Management side was of the view that due to raising cost and increase in salary of staff every year atleast 10% of fees should be increased.
